

## MECCA™ 2000 SOFTWARE LICENSE AGREEMENT

*CAREFULLY READ ALL OF THE TERMS AND CONDITIONS OF THIS AGREEMENT PRIOR TO OPENING AND INSTALLING THE SOFTWARE PACKAGE. OPENING AND INSTALLING THE SOFTWARE PACKAGE INDICATES YOUR ACCEPTANCE OF THESE TERMS AND CONDITIONS.*

*TO ACTIVATE WARRANTY, you MUST RETURN the accompanying Customer Registration Form within five (5) days of installing the software package.*

- 1. PERMITTED USES.** You may use the MECCA 2000 SOFTWARE on the single computer system designated by you on the Customer Registration Form which you must complete and return to AMGRAF, INC. within five (5) days of installing the MECCA 2000 SOFTWARE package. If you wish to use the MECCA 2000 SOFTWARE on a computer system other than the one designated by you on the Customer Registration form, you must obtain a new and separate License from AMGRAF, INC. for each such additional computer system.
- 2. USES NOT PERMITTED.** You may not electronically transfer the MECCA 2000 SOFTWARE. You may not make any copies of the MECCA 2000 SOFTWARE BINARY OBJECT CODE (except that you may make one (1) copy of the MECCA 2000 SOFTWARE solely for your own backup purposes) or the SOFTWARE DOCUMENTATION (except that you may make margin notes in the Manuals for your own use). You may not assign or grant sublicenses, leases, or other rights or obligations to the MECCA 2000 SOFTWARE or the USER MANUAL to others, nor may your copy or other copies of the MECCA 2000 SOFTWARE or USER MANUAL be distributed to others. You may not use the MECCA 2000 SOFTWARE on a computer system other than the one designated by you on the Customer Registration Form. You may not reverse engineer, disassemble, reverse translate, or in any way derive from it any MECCA 2000 source code. You may not transmit the MECCA 2000 SOFTWARE to countries prohibited by the U.S. Federal Government.
- 3. BACKUP COPY.** You may make one (1) copy of the MECCA 2000 SOFTWARE solely for your own backup purposes. You must reproduce and include any copyrights, trademark notices, and legends on the backup copy. You must maintain an accurate record of the location of the backup copy at all times.
- 4. COPYRIGHTS, TRADEMARK NOTICES, LOGOS AND LEGENDS.** The MECCA 2000 SOFTWARE and USER MANUALS, logos, product names and other support materials, if any, are either patented, copyrighted, trademarked, or otherwise proprietary to AMGRAF, INC. or its suppliers. You agree never to remove any such notices and product identification.
- 5. TERM.** This License Agreement is effective until terminated. You may terminate this License Agreement by destroying the MECCA 2000 SOFTWARE and USER MANUAL and all copies thereof. This License Agreement will also terminate if you fail to comply with any term or condition herein. You agree upon such termination by AMGRAF, INC. to destroy all copies of the MECCA 2000 SOFTWARE and USER MANUAL, and to certify to AMGRAF, INC. that they have been destroyed. Upon termination, there will be no refund of any monies or other consideration paid by you.
- 6. LIMITED WARRANTY.** THE MECCA 2000 SOFTWARE AND USER MANUAL IS PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY

AND FITNESS FOR A PARTICULAR PURPOSE. THE ENTIRE RISK AS TO THE QUALITY AND PERFORMANCE OF THE MECCA 2000 SOFTWARE AND USER MANUAL IS WITH YOU. SHOULD THE MECCA 2000 SOFTWARE AND USER MANUAL PROVE DEFECTIVE, YOU (AND NOT AMGRAF, INC. NOR ANY AUTHORIZED REPRESENTATIVE OF AMGRAF, INC.) ASSUME THE ENTIRE COST OF ALL NECESSARY SERVICING, REPAIR OR CORRECTION.

SOME STATES DO NOT ALLOW THE EXCLUSION OF IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION MAY NOT APPLY TO YOU. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE.

AMGRAF, INC. does not warrant that the function contained in the MECCA 2000 SOFTWARE will meet your requirements or that the operation of the MECCA 2000 SOFTWARE will be uninterrupted or error free. However, AMGRAF, INC. warrants the media on which the MECCA 2000 SOFTWARE is furnished, to be free from defects in material and workmanship under normal use for a period of thirty (30) days from the date of delivery to you as evidenced by your completed and returned Customer Registration Form which you must complete and return within five (5) days of installing the SOFTWARE package.

7. **LIMITATION OF REMEDIES.** AMGRAF, INC.'S entire liability and your exclusive remedy shall be:
- a. Refund of purchase price within ten (10) days IF the complete software package is returned to the originating dealer with a copy of dated Proof of Purchase.
  - b. The replacement of any media not meeting AMGRAF, INC.'S "Limited Warranty" which is returned, with a copy of your dated Proof of Purchase to AMGRAF, INC. within thirty (30) days of purchase.
  - c. Termination of this License Agreement, and refund of your licensing fee, by returning the MECCA 2000 SOFTWARE and SOFTWARE DOCUMENTATION and all copies thereof to dealer, if AMGRAF, INC. or its authorized representative is unable to deliver replacement media which is free of defects, found within thirty (30) days of purchase, in materials or workmanship.

IN NO EVENT WILL AMGRAF, INC. OR ITS SUPPLIERS BE LIABLE TO YOU FOR ANY DAMAGES, INCLUDING ANY LOST PROFITS, LOST SAVINGS OR OTHER INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING OUT OF THE USE OR INABILITY TO USE SUCH MECCA 2000 SOFTWARE AND USER MANUAL EVEN IF AMGRAF, INC. OR AN AUTHORIZED REPRESENTATIVE OF AMGRAF, INC. HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGE OR FOR ANY CLAIM BY ANY OTHER PARTY. IN ADDITION, AMGRAF, INC. OR ITS SUPPLIERS SHALL NOT BE LIABLE FOR ANY CLAIM BY YOU OR ANY OTHER PARTY FOR DAMAGES ARISING OUT OF THE USE OR INABILITY TO USE SUCH MECCA 2000 SOFTWARE AND USER MANUAL AND BASED UPON STRICT LIABILITY OR AMGRAF, INC.'S NEGLIGENCE.

SOME STATES DO NOT ALLOW THE LIMITATION OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU.

8. **UPDATE POLICY.** AMGRAF, INC. may, at its sole discretion, advise you of, and license your use of PRODUCT UPDATES and NEW RELEASES of the MECCA 2000 SOFTWARE at the current prices for such PRODUCT UPDATES and NEW RELEASES. In order to be advised of or to be licensed for the use of such PRODUCT UPDATES and NEW RELEASES you must complete and return the attached Customer Registration Form to AMGRAF, INC.. ALL PRODUCT UPDATES and NEW RELEASES which are provided to you shall be governed by the same terms of this License Agreement.
9. **MISCELLANEOUS.** This License Agreement shall be governed by the laws of the State of Missouri, and shall inure to the benefit of AMGRAF, INC., its successors, administrators, heirs and assigns. If any legal action is brought by either party to this License Agreement regarding the subject matter of this License Agreement, the prevailing party shall be entitled to recover, in addition to any other relief, reasonable attorney's fees and expenses.
10. **SEVERABILITY CLAUSE.** In the event that one or more of the provisions contained in this Agreement shall be invalid, illegal or unenforceable in any respect under any applicable statute or rule of law, then such provision shall be considered inoperable to the extent of such invalidity, illegality or unenforceability and the remainder of this Agreement shall continue in full force and effect. The parties hereto agree to replace any such invalid, illegal or unenforceable provision with a new provision which has the most nearly similar permissible economic or other effect.
11. **ACKNOWLEDGEMENT.** BY OPENING THE SOFTWARE PACKAGE YOU ACKNOWLEDGE THAT YOU HAVE READ THIS AGREEMENT, UNDERSTAND IT, AND AGREE TO BE BOUND BY ITS TERMS AND CONDITIONS. YOU ALSO AGREE THAT THIS AGREEMENT IS THE COMPLETE AND EXCLUSIVE STATEMENT OF AGREEMENT BETWEEN THE PARTIES AND SUPERSEDES ALL PROPOSALS OR PRIOR AGREEMENTS, ORAL OR WRITTEN, AND ANY OTHER COMMUNICATION BETWEEN THE PARTIES RELATING TO THE SUBJECT MATTER OF THIS AGREEMENT.
